Important Information

I understand that:

1. Prior to receiving any rule books or training material, I must pay the clinic fee of \$55.00
2. I must attend the clinic classes during the summer that will run from late July through Mid September
3. I must successfully pass a written and practical exam before being accepted as a probationary member of the ECBAFO
4. I must submit information for and be subject to a Background Criminal Check
5. Upon being accepted as a probationary member that the remainder of my annual dues for this year of \$55.00 must be paid before any game assignments are made
6. I will be expected to acquire the approved minimum uniform, accessories, and tools needed to officiate
7. Scheduling of all meetings, games and other requirements is conducted via the internet and thus access to a computer on a daily basis is required
8. I will be required to work 3 free games (uncompensated) at the sub varsity level (this does not include youth games) prior to being assigned to any paid games
9. Game fees are paid by the schools or other organizations we service directly to me as an independent contractor and I am responsible for any and all taxes which might be incurred
10. All paid games incur a 7% assessment that I must pay to the Board's assigners to compensate them for their time and that these assessments will be due at the annual business meeting
11. All members are expected to attend all meetings throughout the season, that the rules interpretation meeting, the mechanics meeting and the annual business meeting have mandatory attendance requirements and that there are monetary fines for missing the meetings
12. As a member with less than 3 years experience, I will be expected to attend mentor meetings that take place one hour before each regular meeting
13. I will not be considered for full membership until the annual business meeting in November and then only upon recommendation by the Better Officiating Committee and Mentor Committee
14. Dues for the following year (equal to one varsity game fee) must be paid at the annual business meeting
15. I will be expected to put significant time and effort into learning the craft of officiating
16. It is unusual for any member with less than 2 years experience to be assigned to a Varsity contest on the field
17. I will be expected to conduct myself in an exemplary manner both while on the field and off the field
